- 4. Bidders are advised to visit actual site before submitting their bids. Bidders must submit along with their bids Firm/Company Registration Certificate, Business Registration Certificate (License), PAN/VAT Registration Certificate, Tax Clearance Certificate/ Extension Letter/Tax return submission evidence for the F/Y [2077/78], Power of Attorney, self decleration letter and Letter of Bid.
- 5. Electronic bids must be submitted through PPMO website www.bolpatra.gov.np/egp on or before 12 HOURS on 2022/03/13(29th Falgun 2078). Bids received after this deadline will be rejected. Hard copy will not be acceptable.
- 6. The bids will be opened in the presence of Bidders' representatives who choose to attend at *1 pm*, on 2022/03/13(29th Falgun 2078) at the The Office of Municipal Executive, Gauriganga Municipality, Chaumala, Kailali.
- 7. Bids under *NCB* must be valid for a period of *90 days* after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of as



mentioned above which shall be valid for 30 days beyond the validity period of the bid i.e.120 days.

- 8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
- 9. The information not mentioned here to make the notice short shall be according to PPA 2063 and PPR 2064.
