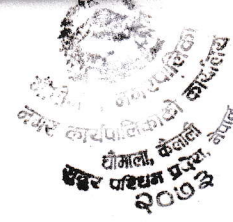

Bidders, submitting their bid electronically, should deposit nonrefundable fee of **NRS 3000** bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 4. Bidders are advised to visit actual site before submitting their bids. Bidders must submit along with their bids Firm/Company Registration Certificate, Business Registration Certificate (License), PAN/VAT Registration Certificate, Tax Clearance Certificate/ Extension Letter/Tax return submission evidence for the F/Y [2079/80], Power of Attorney, self-declaration letter and Letter of Bid.
5. Electronic bids must be submitted through PPMO website www.bolpatra.gov.np/egp or before **12 HOURS** on **2023/09/27, 10 Ashoj, 2080**. The bids will be opened at **1 pm, 2023/09/27, 10 Ashoj, 2080** at, **Gauriganga Municipality Office, Chaumala, Kailali**. Bids must be valid for a period of **90** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of as mentioned above which shall be valid for 30 days beyond the validity period of the bid.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
